# **TERMS & CONDITIONS**

## **MARITIME, MARINE RESCUE & SAFETY**

All boats must carry safety equipment as required by NSW Maritime. It is the responsibility of each competitor to acquaint themselves with these requirements.

All boat owners must log on and off with Eden Marine Rescue or by the Marine Rescue App. At all times you must act responsibility and be aware of your own and other competitors' safety. This includes not going to sea when weather conditions are considered unsatisfactory. If unsure contact Eden Marine Rescue for a weather update and if necessary, choose a safer fishing option.

As the competition will include open waters competitors will need to fully acquaint themselves with bar and sea conditions and make their own decisions as to whether to attempt bar crossings and proceed to sea.

Personal Data collected during registration or during the event will not be sold to any organisation or given to a third party.

Email addresses and phone numbers are required for administration and may be passed onto police and or rescue services

### LIABILITY:

**EAFC** will not accept any liability for any injury, loss or damage of any kind. It will be the responsibility of each skipper, crew and entrant whether or not to start or continue the Competition. Due to legal liability requirements each entrant will need to acknowledge at time of entry.

We will not be liable for any losses to any party and shall not be liable for any expenditure (eg. travel and accommodation), damage or loss incurred by the entrant.

Unfortunately, we may need to alter the program prior to or during the competition and reserve the right to do so without notice. We also reserve the right to change the format of the event when precautions cannot be implemented or adequately communicated.

### **DISPUTES & RESOLUTION PROCESS**

The organising committee reserve the right to adjudicate as is and if necessary, in the event of any dispute.

Any competitor wishing to lodge a protest may do so in writing to a Committee member.

### Cancellation & Refunds:

The EAFC reserves the right to vary the rules of the competition, promotion or any prizes offered or cancel the competition if we are no longer able to run the competition due to reasons beyond our control, subject to State or Territory legislations including any COVID-19. health guidelines.

If EAFC cancels the Competition, a refund will be offered to entrants upon request or unless instructed to retain for the next competition.

Liability will be limited to the amount of the fee paid by the entrant.

Where an entrant has a paid confirmed registration and chooses not to attend due to any situation, a full refund will not be available.

### **COVID SAFE GUIDELINES & CONDITIONS**

# Registered Entrants Agree To:

- : That all contact information will be available to public health officers upon request.
- : The Competition organisers will not share contact information with any third party other than the relevant health authority and will not use the information for promotional purposes.
- : Are required to bring their own masks.
- : Must not attend if they are experiencing any flu-like symptoms (sore throat, runny nose, persistent cough, shortness of breath, fever).
